This agreement is made between _____, hereinafter referred to as the 'seller' of Kahali Cattery and _____, hereinafter referred to as the 'purchaser'.

By giving us form of payment for purchase of cat/kitten(s) you have automatically accepted terms of our contract. All kitten/cat sales through Kahali Cattery are covered by the terms of contract regardless of signature/s. Agreement may be verbal, electronic or written. It is the purchaser's responsibility to review terms of contract.

Whereby it is agreed as follows:

The PURCHASER agrees to and understands the following conditions:

Health Guarantee and Personality

1. The cat is being transferred to the purchaser with the understanding that the adopter is taking possession of the cat to treat and to be responsible for it as their own cat. The cat will be treated as a family member with loving care and affection. The purchaser will do their best to ensure the cat's safety and well-being. The cat will live inside only.
2. The purchaser is obtaining the cat for themselves and agrees not to give away, sell, or trade the cat, even as a gift to a friend or family member without first obtaining consent from the seller. The purchaser will neither take the cat to a shelter nor abandon the cat. The purchaser understands that they must notify the seller, without delay; the seller reserves first right to require the animal. Cat may be returned to the cattery at purchaser's expense within 5 days (unless other arrangements have been made with seller) for a full refund less any delivery expenses.

3. VACCINATION WITH FIP VACCINE WILL VOID THIS CONTRACT.
4. The purchaser agrees not to declaw the cat.
5. The purchaser has today examined the kitten/cat and is satisfied with the health and temperament of the kitten/cat.
6. There is no guarantee of health or temperament of the animal you are purchasing, and you release the seller from any and all claims of liability.
7. Purchaser is responsible for all veterinarian fees and other expenses which are incurred from date of kitten/cat leaving cattery. The purchaser agrees to provide the cat with all required and/or needed veterinary care as recommended by the attending veterinarian including but not limited to: vaccines, fecal check for internal parasites, and prompt treatment by a licensed veterinarian for any illness or injury.
8. The seller is not responsible for any stress induced health issues that affect the kitten/cat once placed in the purchaser's residence.
9. Purchasers is acquiring this cat as a companion animal and not for breeding purposes.
10. If the purchaser's premises are a multi cat home then it is the purchaser's responsibility to isolate the kitten/cat for at least two week before introduction to other kittens/cats already established in the purchases home.
11. The cat should remain on the same feeding regimen when leaving the cattery for at least two weeks. The seller is not responsible for any issues that may occur from switching foods too fast or to a lesser quality of food than what was suggested.

Please Note: Kitten/cat will come with a registration slip from parent club after proof of spay/neuter procedure, and third set of shots. Kitten/cat registration and the cost of registration is the sole responsibility of the purchaser. Registration form/papers for kitten/cat purchased as a pet will be marked "NOT FOR BREEDING."

This contract is a binding contract between purchaser and seller, which may be enforced by seller through judicial proceedings, including the right to recover the cat due to my breach of this contract.
